I am pleased to advise you that the above-mentioned fire protection district within the province of British Columbia was recently re-registered in the fire insurance grading index as being accredited for the delivery of Superior Tanker Shuttle Service.

The requirements for this accreditation are stringent and verify that the fire protection district is capable of delivering the minimum accepted fire flows to detached dwellings throughout the fire protection district and within 8 kilometres by road of the responding fire station. This accreditation is an equivalency to the minimum requirements for hydrant protection as set out by the insurance industry and the Fire Underwriters Survey.

Fire Underwriters Survey has provided information on fire protection and risk levels to the insurance industry in Canada since 1883. Fire Underwriters Survey was previously operated under the auspices of the Insurers Advisory Organization and CGI, however is now operated by SCM Risk Management Services.

Re: Superior Tanker Shuttle Accreditation Effective November 22nd 2018

I am pleased to advise you that the Fire Underwriters Survey has evaluated your test results and application for reaccreditation to deliver Superior Tanker Shuttle Service and has determined that Fire Station #1, #2, and #3 qualify for re-accreditation.

Please find the enclosed certificate of accreditation and a brief letter of recognition.

As an accredited agency, constituents within your fire protection district who own detached dwellings and are within 8km of an accredited fire hall and 5km of a water supply point conforming to NFPA 1142 — Standard on Water Supplies for Suburban and Rural Fire Fighting, recent edition, are eligible to receive a significant cost reduction in their fire insurance rates from the majority of insurers in Canada. It should be noted that a reaccreditation process will occur five years from the date of this letter. Insurers utilize the information provided by Fire Underwriters Survey in setting the property insurance rates throughout Canada. Insurers are advised that Superior Tanker Shuttle Accredited fire protection districts qualify for hydrant protected equivalency status and may be rated as protected. Note that this equivalency applies only to detached dwellings without exposures.

It should also be noted that insures are under no obligation to accept this equivalency; however, the Fire Underwriters Survey recommends that they do so.

As a Surveyor for Fire Underwriters Survey, I must advise you that Superior Tanker Shuttle Accreditation and benefits associated with the accreditation are contingent upon the fire protection district being capable of continuously meeting the requirements of the Superior Tanker Shuttle service delivery and being continuously able to provide evidence of such capacity upon request. Should the capacity of the fire protection district to deliver this level of service change at any time, notification should be made immediately to the offices of Fire Underwriters Survey. Fire Underwriters Survey retains the right to revoke Superior Tanker Shuttle Accreditation at any time.
